Retain the current Capped Pricing model

All suppliers awarded to Lot if meet Quality Criteria – Assessment of Needs

Lots 11 & 12 – if awarded to Lots 1 -10 supplier can add products to Lot 11 & 12.

Specific labelling can be included within ITT essential criteria. (CE/UKCA, Latex marking)

Packaging can be evaluated from Artwork – PASS/FAIL (Suppliers can send PDF) minimum criteria can be found in MDR regulations.

Some of the CSR criteria such as anti-slavery, corruption and Full Life Cycle Assessment of products are requested in the mandatory section of the ITT on a PASS/FAIL

What Product Support is available, Reps, product support materials (literature, videos)

Clinical reference in English or translated to English

Requirement for product support representation

Product Support/Educational Support (Literature/Online Videos/YouTube/Face to Face)

Sustainability questions are required. Consensus that if company has no Sustainability Policy they should be excluded

All NHS Procurement requires a Climate Change sustainability risk assessment as mandated by Scottish Government.

As part of our practices, we need to ask for literature in different formats.

Mandatory aftercare policy (non-scoring)

Rebate scheme

£1.2m annually consists of:

SLWG Stoma Garment Review Panel

An outstanding action from Scottish Stoma Clinical Nurse Specialist Group Effective use of Support Garments for parastomal Hernia. Results of Short Life Working Group (November 2017) was to Identify the process to implement the revised Level 1 & 2 garments across NHSS. To implement this, we require to form a panel from the CAP to identify the process and to review any supplier applications for garments to be added to the Scottish Drug Tariff as a Level 2 Garments,

This will be led by NP but will require clinical input to ensure a robust process.

Members of the panel will not be identified to external parties and decisions will be identified as having been made by a consensus decision of the clinician members of the NHS Scotland Stoma Garment Review Panel.
