The date on which the Framework Agreement shall come into effect shall be 1st April 2024 (“Effective Date”).

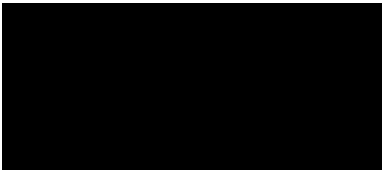
