**Freedom of Information Reference: FOI-2025-3159 – PANS/PANDAS Steering Group.**

I refer to your freedom of information request that we received on 04 November 2025 requesting the following information.

I am writing to request information under the Freedom of Information (Scotland) Act 2002 regarding NHS National Services Scotland's response to recent communications about Paediatric Acute-onset Neuropsychiatric Syndrome (PANS) and Paediatric Autoimmune Neuropsychiatric Disorders Associated with Streptococcal infections (PANDAS).

In May 2025, the PANS PANDAS Steering Group (PPSG) wrote to the chief executive of all NHS boards in Scotland to inform them of the ongoing work in the development of clinical guidelines for PANS and PANDAS. A link to this, and other referenced communication and statements can be found at the bottom of this email

Referenced in that letter, is a letter written by Neil Gray MSP, Cabinet Secretary for Health and Social Care to Wendy Chamberlain MP, outlining the support available in Scotland for those affected, as well as confirmation that the Department for Health and Social Care in England officially recognises that the PPCG 2023 statement supersedes the 2021 BPNA Consensus Statement.

A request was made to the Cabinet Secretary to confirm if this was also the status in Scotland, but we were informed that we would need to make that request to each individual NHS board in Scotland.

With that in mind, could you please provide responses to the following:
