

# Safety Action Notice

## MDR preparedness: DL(2024)32 - national adverse incident reporting and safety alert systems

### Summary

Health boards and local authorities must maintain systems for managing adverse events and safety alerts. This notice updates the obligations outlined in Directorate Letter [DL\(2024\)32](#), *Safety of Health, Social Care, Estates and Facilities Equipment: NHS Board and Local Authority Responsibilities*, issued by Scottish Government on 16 December 2024.

### Action

#### 1. Annually review local systems to ensure:

- a) identification, recording and reviewing of adverse events
- b) reporting incidents to **IRIC** ([report an incident](#))
- c) trend analysis and sharing of learning from adverse events
- d) management of safety alerts

#### 2. Appointment of an Incidents and Alerts Safety Officer (IASO)

- a) ensure the IASO is supported and enabled to function at corporate level
- b) put in place arrangements for continuity of cover.

#### 3. Complete the [Directorate Letter DL\(2024\)32 survey](#) to help assess compliance.

#### 4. NHS Boards - ensure the ISO has ready access to:

- a) executive lead for management of serious adverse events
- b) quality improvement lead
- c) procurement lead
- d) medical devices committee and/or head of medical physics

## Background Information

Health boards and local authorities have a duty to deliver care services safely. Learning from adverse events and managing safety alerts are essential to this duty<sup>1</sup>. IRIC provides specialist support for medical devices, in-vitro diagnostic devices (IVDs), estates and facilities, social care equipment, and personal protective equipment (PPE)<sup>2,3</sup>.

IRIC delivers national adverse incident and safety alert systems which cover all services provided by health boards, local authorities, partnerships, and contractors. This makes the obligations outlined in [DL\(2024\)32](#) integral to NHS Boards' and Local Authorities compliance with medical device regulation preparedness and post market surveillance requirements.

For NHS organisations, IRIC services align with the Healthcare Improvement Scotland (HIS) Framework for Reviewing and Learning from Adverse Events, which requires boards to manage adverse events through reporting, review, and improvement planning. Resources are available via Healthcare Improvement Scotland's website<sup>1</sup>.
